## Oral Statement from Lawyers for Lawyers

United Nations Human Rights Committee's review of the 7th Periodic Report of Colombia  
Formal NGO briefing, Geneva, 17 October 2016

Lawyers for Lawyers<sup>i</sup> would like to draw the Committee's attention to the failure of the Colombian authorities to ensure the right of access to justice and effective legal representation.<sup>ii</sup> **Despite the current peace negotiations, lawyers are increasingly being threatened, physically attacked and even murdered because of their work.** The violence targets in particular the human rights lawyers who defend the victims of the armed conflict living in remote areas.<sup>iii</sup> **Also lawyers' relatives are being threatened.**

Lawyers for Lawyers welcomes the establishment of the UNP<sup>iv</sup>, but would like to stress that **the protective measures for endangered lawyers are often insufficient and ineffective.** Moreover, **attacks against lawyers often remain unpunished.**

Colombian lawyers continue working with the fear that they and their family members may be in danger, potentially forcing lawyers to renounce certain kinds of cases. **This chilling effect on the legal profession directly impedes access to justice for citizens.**

During our mission to Colombia at the end of last August, we met Adil Meléndez, He is one of the few lawyers in the northern region of Bolívar who still works on cases in the field of land restitution and the prosecution of paramilitaries. As a result, he continually faces threats and harassment. The protective measures provided by the UNP are insufficient to enable him to practice his profession effectively. Despite that his work requires him to travel to remote areas, his bulletproof transport is restricted to the city of Cartagena and only partly financed.

Lawyers for Lawyers would like to call on the Committee to strengthen its previous recommendations for Colombia to **take effective steps to guarantee the security of human rights lawyers** both by strengthening the protection program and by effectively investigating threats against lawyers.

A group consisting of 70 lawyers, judges and public prosecutors visited Colombia to investigate the situation of the legal profession in the country. Colombian lawyers informed Lawyers for Lawyers that, despite the current peace negotiations, the threats against lawyers are increasing, in particular against human rights lawyers who defend the rights of the victims of the armed conflict in remote areas. <sup>iv</sup> In their reply to the List of Issues, the Colombian authorities stated that the "Prevention and Protection Program by the National Unit Protection (UNP) seeks to guarantee the rights to life, integrity, freedom and security of persons, groups and communities who are at extreme risk as a direct result of the exercise of their political, public, social or humanitarian activities, or because of the exercise of their profession. At present the UNP implements protective measures for 133 judges and 10 lawyers and legal representatives, who because of their practice face some risk. Also, the UNP has assigned 15 protection schemes to public prosecutors."
